## **S**YNOPSIS

A resolution has been prepared to authorize the extension of existing contracts for material testing services for capital improvement projects for an amount up \$55,000 for each contract with the following companies:

- INTERRA, Inc., of Bolingbrook, Illinois
- SEECO Consultants, Inc., of Tinley Park, Illinois; and
- GEOCON Professional Services, of Frankfort, Illinois.

## BACKGROUND

These companies were previously pre-qualified by the Village for material testing services through a Request for Qualifications that was issued in 2016. Unit rates for required testing services were solicited from the prequalified consultants, with all three firms responding. After reviewing the proposals, SEECO Consultants, Interra, Inc., and Geocon Professional Services were all identified as firms that best meet the needs of the Village.

The three firms have agreed to hold their hourly rates for the work proposed in 2018 with minor modifications. As such, staff is recommending a contract extension in lieu of advertising a new Request for Proposals. Staff will work with the companies' personnel to develop a scope of work for each project, similar to those

performed in 2016, but which will be dynamic and reflect the specific identified needs of each site. Each contract is in an amount not-to-exceed \$50,000 plus a 10% (\$5,000) contingency and services would be authorized under specific work orders with individual not-to-exceed amounts and in accordance with the unit prices specified within the contracts.

The three companies have satisfactorily provided material testing services for capital improvements projects in 2013, 2014, 2015, and 2016.

#### SECOND EXTENSION TO THE CONTRACT BETWEEN THE VILLAGE OF DOWNERS GROVE AND SEECO CONSULTANTS, INC

The Village of Downers Grove, Illinois and SEECO Consultants, Inc entered into a contract on or about April 12, 2016. This extension represents the second extension for this contract. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

- 1. The contract shall be extended for a one-year period, ending April 12, 2019.
- 2. The total not-to-exceed amount shall remain at \$55,000. All unit prices shall remain the same as the 2016 rates except for the following shall increase Project Engineer from \$120/hour to \$124/hour and Field Technician from \$104/hour to \$109/hour. - 3. All other terms from the April 12, 2016 contract remain in full force and effect.
