#### **SYNOPSIS**

A resolution has been prepared to authorize an extension of a three-year contract for footwear for the Village Fire Department with Redwing Shoes of Downers Grove, Illinois in an amount not to exceed \$45,000.

#### **BACKGROUND**

The Village provides uniforms, including footwear (work boots and shoes) for employees of the Fire Department per the terms of the collective bargaining agreement. The Village has two contracts, awarded through a bid process, with Unique Apparel Solutions and Redwing Shoes. Employees have the option of purchasing their preferred boots through either vendor through their allotted uniform allowance. Redwing has agreed to extend the 2015 agreement for an additional 3 years at no price increase.

# EXTENSION TO THE AGREEMENT BETWEEN THE VILLAGE OF DOWNERS GROVE AND REDWING SHOES

The Village of Downers Grove, Illinois and Redwing Shoes entered into a three-year Agreement ("Agreement") to provide footwear for the Fire Department on or about August 4, 2015. Pursuant to the terms of the Agreement, the parties desire to enter into an extension to the Agreement for a period of three years under the following terms:

- 1. This extension shall be for a term of three years, ending July 31, 2021.
- 2. The total not-to-exceed amount for the three-year period is \$45,000.00; with a not-to-exceed amount of \$15,000.00 for each year. Individual items shall be at the rates listed on Exhibit A attached hereto.
- 3. All other terms from the 2015 Agreement remain in full force and effect.
