#### **SYNOPSIS**

A resolution is requested to authorize the use of local funds in addition to the amount included in the Local Agency Agreement between the Village of Downers Grove and Illinois Department of Transportation (IDOT) to fund the resurfacing of Maple Avenue between Main Street and Fairview Avenue.

### STRATEGIC PLAN ALIGNMENT

The Goals for 2017 to 2019 identified Top Quality Infrastructure.

### **FISCAL IMPACT**

The total project cost is \$415,550. The Village's local share of the project \$148,550. The FY2018 Budget includes \$115,000 in the Capital Fund (Page 4-17 Line 20) for the Village's local share. Additional funds in the amount of \$33,550 are available in the Capital Fund.

## RECOMMENDATION

Approval on the September 11, 2018 consent agenda.

#### **BACKGROUND**

The Village approved a Local Agency Agreement on May 15, 2018 as Resolution No. 2018-34 that sets the funding obligations for each party to resurface Maple Avenue between Main Street and Fairview Avenue. The agreement includes a grant under the federal Surface Transportation Program in the amount of \$267,000 of the total project cost. The Village's funding obligation amount per the agreement is \$115,000, or as much as needed to match Federal Funds.

IDOT conducted the letting for the project and bids were received by IDOT on August 3, 2018. IDOT reviewed the bids submitted and requested the Village's concurrence for the award to the lowest responsive, responsible bid amount of \$415,550. This low bid amount is within 0.6% of the engineer's estimated cost for the project. The Village's funding obligation will increase an additional amount of \$33,550 from \$115,000 to \$148,550 based on the low bid amount of \$415,550. Construction is anticipated for the fall of 2018.

BE IT RESOLVED by the Village Council of the Village of Downers Grove, DuPage County, Illinois as follows:

Section 1. Whereas, on May 15, 2018, the Village Council adopted Resolution 2018-34 entitled "A RESOLUTION AUTHORIZING EXECUTION OF A LOCAL AGENCY AGREEMENT BETWEEN THE VILLAGE OF DOWNERS GROVE AND THE ILLINOIS DEPARTMENT OF TRANSPORTATION FOR MAPLE AVENUE STREET RESURFACING" which approved a Local Agency Agreement for Federal Participation to fund 70% of the project with FHWA funds (not to exceed \$267,000).

<u>Section 2</u>. The Federal fund source required a match of local funds in the amount of \$115,000.

Section 3. Due to an increase in the Federal fund source, the match of local funds is hereby amended to \$148,550, representing a \$33,550 increase in the local fund match.

<u>Section 4.</u> The Village of Downers Grove has appropriated sufficient funds in the Village's Capital Project Fund.

Section 5. That all other terms and conditions of the Agreement, between the Village of Downers Grove (the "Local Agency" or "LA") and the Illinois Department of Transportation (the "State"), Job Number C-91-148-18 and Section 18-00113-00-RS, for road resurfacing of Maple Avenue from Main Street to Fairview Avenue remain unchanged.

<u>Section 6</u>. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Amendment.
