#### **SYNOPSIS**

Resolutions have been prepared to authorize extensions to two individual contracts for one year each for stormwater related development review services with Engineering Resources Associates (ERA) and Robinson Engineering, Ltd., in a not-to-exceed amount of \$70,000 per contract.

#### STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include Exceptional Municipal Services.

#### **FISCAL IMPACT**

The FY19 Budget includes \$140,000 in the General Fund (Page 4-19, Line 19) for development review services specifically associated with stormwater and wetland permit reviews. The majority of this expense is recaptured through development related fees paid by permit applicants.

#### RECOMMENDATION

Approval on the December 4, 2018 consent agenda.

#### **BACKGROUND**

In December 2015, the Village entered into separate three year contracts with ERA and Robinson Engineering for development review services with options for two one-year extensions. Both consultants assist the Community Development Department by reviewing permit applications that contain challenging stormwater, grading and wetland issues with potential impacts which are not always evident. This occurs in a complex regulatory environment, with the Village having full waiver status and responsibility for enforcing the stormwater ordinance.

Staff is satisfied with the quality of the work performed by both ERA and Robinson. If approved, this would be the first extension of the contracts.

# EXTENSION TO THE CONTRACT BETWEEN THE VILLAGE OF DOWNERS GROVE AND ENGINEERING RESOURCE ASSOCIATES

The Village of Downers Grove, Illinois (the "Village") and Engineering Resource Associates ("Consultant") entered into a three-year Contract for development review services relating to stormwater and wetland matters on or about December 15, 2015. The Contract was amended on June 14, 2016 to increase the not-to-exceed annual amount to \$70,000. The parties desire to extend the amended Contract in accordance with the following terms:

- 1. The Contract shall be extended for a one-year period through December 31, 2019.
- 2. The Not-to-Exceed contract amount shall remain at \$70,000 for 2019.
- 3. All other terms from the December 15, 2015 Contract and June 14, 2016 amendment shall remain in full force and effect.
