1. Call to Order

Mayor Pro Tem William White called the regular meeting of the Village Council of the Village of Downers Grove to order at 7:00 p.m. in the Council Chambers of the Downers Grove Village Hall. He explained that Mayor Tully is out of town on business and would not be in attendance at tonight's meeting.

Pledge of Allegiance to the Flag

Mayor White led those present in the Pledge of Allegiance to the Flag.

2. Roll Call

The Council meeting is broadcast over the local FM radio station, WDGC. In addition, a tape recording and videotape of the meeting are being made using Village-owned equipment. The videotape of the meeting will be used for later rebroadcast of the Council meeting over the Village cable television Channel 6.

The Council will follow the rules of conduct for this meeting as provided in Sec. 2.5 of the Downers Grove Municipal Code. These offer the public the opportunity to comment at several points in the meeting. First, immediately following approval of the minutes of past meetings, an opportunity will be given for public comments and questions of a general nature. If a public hearing is scheduled for this meeting, an opportunity is given for public comments and questions related to the subject of the hearing. Finally, an opportunity is given for public comments and questions on items appearing on the Consent Agenda, the Active Agenda and the First Reading.

At the appropriate time the presiding officer will ask if there are any comments from the public. Individuals wishing to speak, should raise their hand to be recognized and, after acknowledgment from the presiding officer, approach the microphone and state their name. Remarks should be limited to five minutes, and individuals are asked to refrain from making repetitive statements.

Agendas are located on either side of the Council Chambers for the audience to follow the progress of the Council meeting.

Motion: Commissioner Earl moved to approve the minutes as presented. Commissioner Waldack seconded the motion.

Mayor White declared the motion carried by voice vote.

4. Presentations

Economic Development Corporation Quarterly Report

Michael Cassa, President and CEO of the Downers Grove Economic Development Corporation (EDC), 5159 Mochel Drive, presented the quarterly report for the EDC. Municipal Sales Tax increased 6.34% from August 2017 to August 2018. The year to date increase is 3.23%. Home Rule Sales Tax increased 2.34% from August 2017 to August 2018 and the year to date increase is .98%.

Mr. Cassa reviewed sales taxes by various categories for the period January through June 2018. Automotive and drugs are the largest categories. Taxes for restaurants should increase due to new restaurants coming online. Food is the category with the greatest loss. Apparel was also down as it is a category that has been hit hard by internet sales; he noted that we are the least dependent on this category. Hotel Tax revenue for January to September increased 1.06% over the same period last year. He noted there will be some decline in the next quarter due to ongoing hotel renovations.

Mr. Cassa then reported on the EDC's current projects. Aldi is now open. Mr. Cassa said it is the fastest growing chain in the U.S. Cooper's Hawk is organizing a ground-breaking ceremony. Two national stores, Bed, Bath and Beyond and Buy Buy Baby, executed lease extensions at Finley Square. He noted the Zeigler Automotive Group expansion at Ogden and Cross. Walgreens at the NW corner of Belmont & 63rd Street will stay at their current location in Downers Grove. Burlington Station, an 89-unit apartment complex at Burlington and Warren, opened. The complex at Main and Maple opened with many units occupied. Green Bay Packaging is now in Downers Grove. Rexnord moved in early October and construction is continuing on that site. Two tenants have signed leases at Bridge Point, located at Lacey and Finley Roads.

In terms of marketing, Mr. Cassa discussed two initiatives in October: the EDC's participation in the International Council of Shopping Centers, and the third annual "Deals Are Brewing."

Mr. Cassa announced the EDC Holiday Open House on December 6 from 4:30 p.m. to 6:30 p.m. He said he will discuss opportunities, goals and challenges at the next meeting.

Commissioner Waldack asked about the Power Mart at Finley and Ogden.

Mr. Cassa said he is waiting for the response from the company to the Village's letter from Community Development. They also need to complete their building application.

Commissioner White said the efforts of the EDC and others is how we keep the tax levy low. Sharing and preparing numbers helps the Council keep track of trends. He complimented Mr. Cassa and the EDC on pursuing a wide variety of business opportunities.

Mr. Cassa said there is a tremendous sense of teamwork in economic development in Downers Grove. He is grateful for the support he gets.

Mayor White said every dollar of sales tax offsets a dollar of property tax.

Mike Baker, Deputy Village Manager, said the 2018 levy, after abatements, is \$13,800,025. The levy for Village operations remains flat. The fire and police pension levies have increased pursuant to state law. The Village's portion of the overall tax bill is 9.6%.

There being no further discussion, the public hearing was adjourned at 7:27 p.m.
