SYNOPSIS

A resolution has been prepared to authorize a contract extension with K-Five Construction Corporation of Westmont, Illinois, for the supply of hot mix asphalt materials until December 31, 2019 for a contract amount of \$50,745.

STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include *Top Quality Infrastructure*.

FISCAL IMPACT

The FY19 Budget provides \$52,100 in the Capital Projects Fund (Page 4-3, Line 16) for the purchase of asphalt materials.

RECOMMENDATION

Approval on the February 19, 2019 Consent Agenda.

BACKGROUND

The contract amount is based on a quantity of 1,000 tons of materials to be used for street repairs at various locations throughout the Village. Asphalt is used by Village crews for pothole and minor street patching. The vendor has agreed to extend the contract until December 31, 2019 with a 2% increase to the contract.

**A RESOLUTION AUTHORIZING EXECUTION OF AN EXTENSION TO THE CONTRACT

BE IT RESOLVED by the Village Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

1. That the form and substance of an Extension (the "Agreement"), between the Village of Downers Grove ("Village") and K-Five Construction Corporation ("Provider"), for supply of hot mix asphalt materials, as set forth in the form of the Agreement submitted to this meeting with the recommendation of the Village Manager, is hereby approved.

That the Village Manager and Village Clerk are hereby respectively authorized and directed for and on behalf of the Village to execute, attest, seal and deliver the Agreement, substantially in the form approved in the foregoing paragraph of this Resolution, together with such changes as the Manager shall deem necessary.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**EXTENSION TO THE CONTRACT BETWEEN
THE VILLAGE OF DOWNERS GROVE AND
K – FIVE CONSTRUCTION CORPORATION**

The Village of Downers Grove, Illinois and K – Five Construction Corporation (“Provider”) entered into a contract for the Supply of Hot Asphalt on or about April 17, 2018. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

1. The contract shall be extended through December 31, 2019.
2. The fees shall increase by 2%, which is an increase of \$995, for a total not-to-exceed new price of \$50,745 for 2019.
3. All other terms from the April 17, 2018 contract remain in full force and effect.
