SYNOPSIS

A motion is requested to approve a building permit fee waiver in the amount of \$9,712.90 for site improvements at Downers Grove North High School, 4436 Main Street.

STRATEGIC PLAN ALIGNMENT

The goals for 2017-2019 include *Top Quality Infrastructure*.

FISCAL IMPACT

Waiver of \$9,712.90 in building permit fees.

RECOMMENDATION

Staff recommends approval on the May 21, 2019 Consent Agenda.

BACKGROUND

School District 99 has applied for a building permit fee waiver in the amount of \$9,712.90. Section 1.29 of the Downers Grove Municipal Code allows the Village Council to waive certain fees for other governmental entities, including all public school districts, at its discretion in conjunction with Council Policy 2002-73. The Policy notes that for public school districts with taxing boundaries that are substantially coterminous with the Village all fees eligible to be waived will be waived up to \$5,000 and seventy percent (70%) of the remaining amount of the fee waiver request will also be waived. When the fee waiver request exceeds \$5,000, Village Council approval is required.

The Downers Grove North project involves the construction of new bleachers, new squad rooms, courtyard improvements and stormwater improvements. Staff finds that School District 99 is an entity eligible to apply for the waiver.
