An ordinance has been prepared to amend the Village Budget for FY20.

# **UPDATE & RECOMMENDATION**

This item was discussed at the April 13, 2021 Village Council meeting. Staff recommends approval on the April 20, 2021 Active Agenda.

# **BACKGROUND**

The Village's FY20 Budget was authorized by ordinance in December 2019 and the Village's fiscal year began on January 1, 2020 and closed on December 31, 2020. The Village has nearly completed the financial closeout of the year and audit work will be conducted in the coming weeks.

Actual FY20 expenses ended the year below budgeted levels for most Village Funds including the General Fund. Three funds were over budget and will require budget amendments:

- Debt Service Capital Fund (\$15,610,000);
- Water Fund (\$1,330,000); and
- Police Pension Fund (\$100,000)

The Debt Service Fund and the Water Fund were over budget due to the refunding of 2012 bonds for Roads and Stormwater, which resulted in \$1.7 million of present value savings to the Village in debt service payments. This is due to the accounting entry required to show the proceeds from the new lower interest rate bond going into the fund (revenue entry) and paying off the old higher interest rate bond coming out of the fund (expense entry). Pension Fund is over budget due to greater than expected retirements in the Police department. In addition, an amendment of \$1,220,000 is requested for the General Fund. Revenues in the General Fund were \$1.3 million lower than budgeted. As a part of the COVID-19 Financial Response plan, expenses in the General Fund were reduced by \$2.0 million. In addition, the Village received \$2.5 million from the CARES Act. Staff is proposing a transfer of \$3.2 million to the Municipal Buildings Fund. The transfer will bring the actual 2020 expenses to \$50.86 million, which is \$1.22 million over budget. This will keep the General Fund fund balance within the range recommended by S&P (40.5%) and provide flexibility in the future to utilize these funds for new facilities.

The recommended budget amendment will increase the overall authorized expense level. The rationale for recommending this amendment is based on the following:

- State law dictates that municipalities cannot spend more than authorized unless a budget amendment is adopted, and;
- This action does not alter the approved spending levels for FY21.

# AN ORDINANCE PROVIDING FOR AN AMENDMENT TO ORDINANCE #5831 AND THE VILLAGE OF DOWNERS GROVE BUDGET FOR FISCAL YEAR 2020
