**SYNOPSIS**

A resolution has been prepared to authorize a contract extension for the provision of roadside drainage ditch reconstruction and maintenance services to Western Gradall Corporation of Naperville, Illinois in the amount of \$45,461.40.

**STRATEGIC PLAN ALIGNMENT**

The goals for 2021-2023 include *Top Quality Infrastructure*.

**FISCAL IMPACT**

The FY22 Budget includes \$45,470 in the Storm Water Fund for roadside drainage ditch reconstruction and maintenance services.

**RECOMMENDATION**

Approval on the January 11, 2022 consent agenda.

**BACKGROUND**

The 2006 Storm Water Master Plan Update identified roadway drainage ditch cleaning (re-grading) as a key maintenance activity for the Village's storm water system. Work is planned to be performed between April and September of this year. The contract amount would result in approximately 7,000 linear feet of drainage ditch maintenance being completed in 2022.

The original contract was awarded in March 2019. The contractor has agreed to a 2% increase in rates for work performed in 2022.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**SECOND EXTENSION TO THE CONTRACT BETWEEN  
THE VILLAGE OF DOWNERS GROVE AND

The Village of Downers Grove, Illinois and Western Gradall Corporation ("Provider") entered into a contract for Roadside Ditch Maintenance Services on or about March 13, 2019. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

1. The contract shall be extended through December 31, 2022.
2. The fees shall increase by 2%, which is an increase of \$891.40, for a total not-to-exceed new price of \$45,461.40 for 2022.
3. All other terms from the March 13, 2019 contract remain in full force and effect.
