**SYNOPSIS**

A resolution has been prepared to authorize a contract extension for the provision of debris hauling services to Marcott Enterprises, Inc of Villa Park, Illinois in an amount of \$85,286.79.

**STRATEGIC PLAN ALIGNMENT**

**FISCAL IMPACT**

The FY22 Budget includes a total of \$131,750 for this contract.

- \$71,750 in the Stormwater Fund and;
- \$60,000 in the Water Fund

**RECOMMENDATION**

Approval on the January 18, 2022 consent agenda.

**BACKGROUND**

This contract was competitively bid in 2020. The contract extension for 2022 includes a 2% increase in the contract unit prices from 2021. The contract amount is based on the hauling and disposal of approximately 355 loads of debris required for street, storm water and water utility system maintenance.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

**SECOND EXTENSION TO THE CONTRACT BETWEEN  
THE VILLAGE OF DOWNERS GROVE AND  
MARCOTT ENTERPRISES, INC.**


The Village of Downers Grove, Illinois and Marcott Enterprises, Inc. ("Provider") entered into a contract for Debris Hauling on or about February 11, 2020. Pursuant to the terms stated therein, the parties desire to extend that contract under the following terms:

1. The contract shall be extended through December 31, 2022.
2. The fees shall increase by 2%, which is an increase of \$1,672.29, for a total not-to-exceed new price of \$85,286.79 for 2022.
