SYNOPSIS

Resolutions have been prepared to authorize a second one-year contract extension with B&F Construction Code Services, Inc. and Safebuilt Illinois, LLC for building inspection services (building, plumbing, electrical, mechanical and energy inspections) in a not to exceed amount of \$31,000 per contract.

STRATEGIC PLAN ALIGNMENT

The goals of 2021 – 2023 include Exceptional Municipal Services.

FISCAL IMPACT

The FY 22 budget includes \$62,000 in the General Fund for these contracts.

RECOMMENDATION

Approval on the February 15, 2022 consent agenda.

BACKGROUND

In February 2020, the Village entered into separate one-year contacts with B&F Construction Code Services, Inc. and Safebuilt Illinois, LLC for building inspection services with options for two one-year extensions. Both contractors have assisted the Community Development Department by completing building, plumbing, electrical, mechanical and energy inspections related to residential and commercial building permits over the past two years.

Staff is satisfied with the quality of work of both B&F Construction Code Services, Inc. and Safebuilt Illinois, LLC. If approved, this would be the second extension of each contract.

SECOND EXTENSION TO THE AGREEMENT BETWEEN THE VILLAGE OF DOWNERS GROVE AND <u>B&F CONSTRUCTION CODE SERVICES, INC.</u>

The Village of Downers Grove, Illinois and B&F Construction Code Services, Inc. ("Provider") entered into an agreement for code inspection services on an as-needed basis, with an effective date of March 1, 2020. Pursuant to the terms stated therein, the parties desire to extend that agreement under the following terms:

- 1. The agreement shall be extended through March 1, 2023.
- 2. All fees listed in the 2020 agreement shall remain the same, with a total not-toexceed fee of Thirty-one Thousand Dollars and No Cents (\$31,000.00).
