SYNOPSIS

A resolution has been prepared authorizing a one-year agreement with Christine Charkewycz, Attorney at Law, for ordinance violation and traffic citation prosecution services for a flat fee of \$29,090.

BACKGROUND

Christine Charkewycz has served as the Village's prosecutor since 2015. Staff is satisfied with her performance and recommends that the prosecution contract be extended. Ms. Charkewycz has knowledge of the Village and experience in code enforcement issues, property maintenance cases and abandoned property issues.

The contract will be for a one year term.

A RESOLUTION AUTHORIZING EXECUTION OF AN AGREEMENT FOR PROSECUTION SERVICES WITH CHRISTINE CHARKEWYCZ

BE IT RESOLVED by the Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

1. That the form and substance of a proposed Agreement (the "Agreement") between the Village of Downers Grove (the "Village"), and Christine Charkewycz (the "Prosecutor") providing for services related to the prosecution of traffic citations and ordinance violations for the Village in the courts of DuPage County, Illinois, for the Village, and other matters related thereto, as set forth in the form of the Agreement submitted to this meeting with the recommendation of the Village Manager, is hereby approved.

2. That the Village Manager and Village Clerk are hereby respectively authorized and directed for and on behalf of the Village to execute, attest, seal and deliver the Agreement, substantially in the form approved in the foregoing paragraph of this Resolution, together with such changes as the Manager shall deem necessary.

3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

 That this Resolution shall be in full force and effect from and after its passage as provided by law.

AN AGREEMENT FOR PROSECUTION SERVICES

This Agreement dated this _____ day of _____, 2022 is made between the Village of Downers Grove (the "Village") and Christine Charkewycz, Attorney at Law (the "Prosecutor").

WHEREAS, the Village is desirous of having a qualified attorney represent the Village for local ordinance violation cases prosecuted in Wheaton.

NOW, THEREFORE, in consideration of the mutual undertakings and promises contained herein, the parties agree to as follows.

<u>Section 1.</u> The Prosecutor, shall prosecute local ordinance violations of the Village of Downers Grove and shall represent the Village at regular Court sessions held at the DuPage County court house in Wheaton designated for said Village's cases during the term of this Agreement.

Section 2. The Village shall pay the Prosecutor a flat fee of Twenty Nine Thousand Ninety Dollars (\$29,090) per year for a one (1) year term commencing June 1st and ending May 31st. Said fee shall be payable in twelve (12) equal monthly installments. This fee shall include compensation for in-court time, preparation, travel time, attendance at meetings with Village staff, telephone conferences, and any and all administrative costs in connection with prosecuting ordinance violation cases. This does not include training or appeals.

<u>Section 3</u>. The Village may designate that individual ordinance violation cases be prosecuted by its Village attorneys.

Section 4. This Agreement will be effective June 1, 2022 through May 31, 2023.

<u>Section 5</u>. A Campaign Disclosure Certificate is required pursuant to the Village of Downers Grove Council Policy on Ethical Standards and is applicable to those campaign contributions made to any member of the sitting Village Council and is provided as an attachment to this Agreement.

Said Campaign Disclosure Certificate requires any individual or entity doing business with the Village to disclose campaign contributions, as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4), made to current members of the Village Council within the five (5) year period preceding the date of the bid or proposal release.

By signing the documents, the Prosecutor agrees to refrain from making any campaign contributions as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4) to any Village Council member and any challengers seeking to serve as a member of the Downers Grove Village Council.

Notwithstanding any provision contained herein to the contrary, this Agreement may be terminated by either party at any time. But, the Prosecutor agrees to give sixty (60) days prior written notice to the Village of Downers Grove.

Said Campaign Disclosure Certificate requires any individual or entity bidding to disclose campaign contributions, as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4), made to current members of the Village Council within the five (5) year period preceding the date of the bid or proposal release.

By signing the bid documents, contractor/proposer/bidder/vendor agrees to refrain from making any campaign contributions as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4) to any Village Council member and any challengers seeking to serve as a member of the Downers Grove Village Council.

Under penalty of perjury, I declare:

Bidder/vendor has <u>not</u> contributed to any elected Village position within the last five (5) years.
