SYNOPSIS

A resolution has been prepared authorizing an amendment to the purchase agreement for one Peterbilt 348 snow plow truck with JX Peterbilt of Bolingbrook, IL, increasing the amount to \$166,858.21, an increase of \$2,439.

STRATEGIC PLAN ALIGNMENT

The goals for 2021-2023 include Exceptional Municipal Services.

FISCAL IMPACT

The FY22 budget includes \$316,000 in the Equipment Replacement Fund for the replacement of two plow trucks. Due to global supply chain issues, the Village only procured one plow truck in FY22.

RECOMMENDATION

Approval on the August 2, 2022 consent agenda.

BACKGROUND

The 2021 vehicle replacement schedule provided for the replacement of two (2) 5-ton plow trucks. In May 2021, the Village Council approved the purchase of two plow trucks from JX Peterbilt for the total price of \$316,004.90. Due to global supply chain issues, that purchase contract was canceled by JX Peterbilt. Subsequently, in December 2021, the Village approved a purchase agreement with JX Peterbilt for the purchase of one Peterbilt 348 snow plow truck, for the price of \$164,419.24. This price included the trade-in of an existing Village plow truck.

Due to increases in material costs, JX Peterbilt notified the Village that the chassis can no longer be provided for the original price quoted. The new price, after accounting for the trade-in, is \$166,858.21, an increase of \$2,438.97. Should the Village choose not to move forward with this price increase, staff believes that obtaining another plow truck would be very difficult and would not be ready until the 2023/2024 snow season. It is also highly likely that any truck ordered now or in the future will be more expensive. This truck chassis has been delivered and is ready to be upfitted with the required equipment. As such, staff recommends the approval of this price increase.
