SYNOPSIS

A resolution has been prepared to approve a Change Order to Attachments A and D to the Contractual Services Agreement and an Amendment to the Software Subscription Agreement with CityView for the implementation and ongoing support for an integration to allow Downers Grove to process over the counter credit card transactions through the CityView software.

STRATEGIC PLAN ALIGNMENT

The goals for 2021 - 2023 include *Exceptional Municipal Services*. Allowing residents and businesses to pay for their building permits in person is considered a high level of customer service.

FISCAL IMPACT

The costs for the Change Order and Software Subscription Agreement are covered by contingencies already approved by Council in the original approval of the CityView contract on February 2, 2021.

- The Change Order for implementing the integration \$7,100.
- The Amendment to the Software Subscription Agreement
 - o \$4,956 annually for the card readers
 - o \$17,520 annually for the 10 additional named users
- There remains a contingency of \$61,354 for implementation costs and \$78,688.50 for software subscription agreement costs.
- The remaining contingencies will be sufficient to cover costs through the remainder of the project and no additional funds are being requested for the Change Order or Amendment.

BACKGROUND

The original software subscription agreement with CityView does not include provisions for the implementation and maintenance of this integration that enables in person credit card transactions. Additionally, the original agreement with CityView called for 40 named user licenses. Upon completing user acceptance testing, the Village has determined that an additional 10 named user licenses are required.

The Change Order will allow CityView to implement the integration and add 10 additional users. The Amendment to the Software Subscription Agreement will support the ongoing maintenance and necessary integration updates for the card readers and provides for 50 named users as opposed to the original 40.

THIS AMENDMENT NO. 1 to the	Software Subscription Agreement (the "Amendment") is dated and

RECITALS

WHEREAS, the parties entered into a Software Subscription Agreement dated February 3, 2021 "Agreement");

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the foregoing and the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

1 Amended Terms - Software and Support-Related Services

1.1 The Schedule A to the Agreement shall be deleted in its entirety and be replaced with the Schedule A in this Amendment.

2 General Provisions

- 2.1 No Other Amendments. Except as specifically modified by this Amendment, the terms of the Agreement, including its schedules, attachments, appendices, and exhibits, shall remain unchanged and in full force and effect and the parties hereto confirm and agree to be bound by all the terms and provisions of the Agreement as amended hereby.
- 2.2 Entire Agreement; Amendment; Waiver. The Agreement, as amended by this Amendment, sets forth the entire agreement and understanding of the parties hereto with respect to the matters contemplated by the Agreement and this Amendment, and supersedes all prior agreements, arrangements, and understandings (whether oral or written) relating to the subject matter thereof. The Agreement may not be amended, waived, discharged, or terminated other than by a written instrument signed by the party against whom enforcement of such amendment, waiver, discharge, or termination is sought.
- 2.3 <u>Counterparts</u>. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
- 2.4 <u>Binding Effect</u>. This Amendment shall be binding upon, and inure to the benefit of, the parties hereto and their respective successors and assigns.

SCHEDULE A FEES AND PAYMENT SCHEDULE

1 PAYMENT TERMS

- 1.1 The Annual Subscription Fees applicable to subsequent annual subscription terms shall be invoiced ninety (90) days in advance of the anniversary of the date set out in the Project Plan when the Software was installed, configured and is ready for testing.
- 1.2 Annual Subscription Fees include a Data Storage limit of 250GB. In the event additional Data Storage is required, it may be purchased at the then current rates (currently \$75/100GB/month)
- 1.3 Invoice Dispute Procedure: If Customer is in receipt of an invoice and believes that the amount invoiced is inaccurate, the Customer will provide Vendor with written notice within thirty (30) business days of receipt of the subject invoice, pursuant to rules promulgated under 50 ILCS 505/1 et seq. Such notice shall contain reasonable detail so Vendor may confirm the issue and respond by either adjusting the invoice or justifying the amounts billed on the invoice. While an invoice, or a portion of an invoice, is under dispute the Customer may withhold payment for those disputed portions but shall remit payment for any undisputed amounts. While an invoice is under dispute, Vendor shall continue to provide Services consistent with this Agreement and shall not suspend the delivery of Services unless it is determined unfeasible to continue to provide Services based on the nature or scope of the dispute

Description of the Requested Change

The Village of Downers Grove, IL would like to add front counter integration with Invoice Cloud and SRED reader – card swiper devices to their current CityView implementation,

This change order covers the annual subscription fees for the front counter (POS) integration with Invoice Cloud, as well as the professional services time to configure and test the integration.

- \$4,956 Subscription Fee (year 1, invoiced on execution of the change order and subject to regular increases)
- \$7,100 Professional Services including development, QA and project management.

It should be noted that Downers Grove is a CityView hosted implementation, which has implications to how the integration needs to be configured and tested.

In addition the Village of Downer's Grove would like to add ten (10) additional CityView Named User Subscriptions - Full Read/Write at an annual cost (year 1) of \$1,460 each for a total cost of \$17,520.

Impact Assessment: Estimated impact to budget, work effort and schedule

The integration requires specific hardware that must be purchased through Invoice Cloud. Any supply chain shortages may have implications to whether this integration can go live at the same time as the rest of the CityView project. This is outside CityView's control.

A Subscription Amendment will be needed to keep "Schedule A" consistent with this change order.
