Windows Server 2022 Datacenter Licenses Purchase	Dave Kenny Director, Information Technology

SYNOPSIS

A motion is requested to authorize the purchase of six (6) Windows Server 2022 Datacenter 16 core licenses from Dell of Round Rock, Texas in an amount of \$24,089.46.

STRATEGIC PLAN ALIGNMENT

The goals for 2021-2023 include *Exceptional Municipal Services*.

FISCAL IMPACT

The FY22 Budget includes \$30,000 in the Equipment Replacement Fund Budget for the licenses.

RECOMMENDATION

Approval on the November 1, 2022 consent agenda.

BACKGROUND

To keep the Village's backend IT services secure and operational, the Village upgrades its servers' operating system (OS) when needed. Microsoft Windows Server is the platform used by the Village and Microsoft eventually moves older OS versions to (end of life) EOL status. This means they are no longer supported and patches will no longer be available. Due to recent server upgrades and planned future upgrades, the Village needs to purchase six (6) Windows Server 2022 Datacenter 16 core OS licenses in order to stay ahead of EOL status as well as handle additional processors being added to our servers.

The Illinois Statewide Microsoft Products Contract offers the lowest priced licensing option available (Microsoft Select). Staff recommends the purchase from the statewide contract holder, Dell, for a total cost of \$24,089.46.
