#### **SYNOPSIS**

A resolution has been prepared to authorize the approval of a second one-year extension of the agreement with BKD, LLP n/k/a FORVIS, LLP for the independent audit for the fiscal year ending December 31, 2022 in an amount of \$85,000.

#### STRATEGIC PLAN ALIGNMENT

The goals for 2021-2023 include Steward of Financial, Environmental and Neighborhood Sustainability.

#### **FISCAL IMPACT**

The audit will be conducted in 2023. The cost for the 2022 financial audit is \$85,000. The FY2023 budget includes \$52,500 for this expense.

#### RECOMMENDATION

Staff recommends approval on the November 15, 2022 consent agenda.

#### **BACKGROUND**

In November 2016, the Village entered into a five-year contract with BKD, LLP (currently FORVIS, LLP) after completion of a competitive proposal process. This contract ended with the FY2020 audit. This contract was extended in January 2022 due to the extensive amount of staff time required to transition to a new audit firm as staff was in the midst of the Enterprise Resource Planning System (ERP) implementation.

Staff recommends a second one-year extension to this contract since the ERP implementation is still ongoing. The Munis financial system went live in April 2022, however Utility Billing and Payroll are still in the legacy system (Eden) with scheduled go-lives in the first quarter of 2023. This will require the audit for FY2022 be conducted with data on two separate financial systems. FORVIS, LLP is familiar with the Village's financial data, internal controls and accounting practices; therefore, this extension will allow staff to continue to work on completing the implementation of the remaining modules in Munis concurrently with the year-end audit. Staff will complete the competitive proposal process for the FY2023 audit.

Governmental Accounting Standards Board Statement No. 87, Leases, went into effect in 2021 and is applicable for audits for fiscal years beginning after June 15, 2021. As such, the Village is required to comply with this GASB for the 2022 audit. Due to the complexity in identifying the scope of work to prepare and audit this GASB, fees for these services will be evaluated at a later date and will be based on the level of

assistance the Village needs from FORVIS to prepare the GASB. Accordingly, a separate agreement or an amendment to this extension will be brought to Council in 2023.

## SECOND EXTENSION TO THE AGREEMENT BETWEEN THE VILLAGE OF DOWNERS GROVE AND BKD, LLP n/k/a FORVIS, LLP

The Village of Downers Grove, Illinois and BKD, LLP ("Consultant") entered into a five-year Agreement for services to perform annual independent audits of the Village's financial statements on or about November 1, 2016. That Agreement was extended for a one-year period ending November 1, 2022. BKD, LLP is now known as FORVIS, LLP. Pursuant to the terms stated therein, the parties desire to extend that contract for a second one-year period under the following terms:
