Public Comments

Janet Whittingham returned to the podium and thanked the Council, naming Commissioners Hosé and Tully for this resolution and for allowing the residents to be able to vote on this topic.

Village Council Comments/Questions

Commissioner Tully explained that the Council voted unanimously to pass an ordinance with extreme limitations on potential video gaming in the Village. He said it was voted on with the caveat of this resolution (regarding a referendum question that would be on the November 5, 2024 election ballot). He said the process has been very public and this is part two oF the Council making good on what they discussed.

Public Comments

Robin Tryloff returned to the podium and asked the Council to direct staff to negotiate the inclusion of affordable housing with the developer and use this as a way to show support to the community by making this a part of the Civic Center Project. She said that LCI Development has experience in this area and that it is a fundamental need in the Village and a stepping stone to economic stability for many families.

Warner Kiunte, resident, referred the Council to the DuPage Housing Authority, stating the Housing Authority normally takes applications for affordable housing throughout DuPage County. However, they are not taking applications at this time. He requested the Council's assistance in this area.

Village Council Comments/Questions

Commissioner Sadowski-Fugitt said that she looks forward to working with LCI and reiterated her support of looking into including affordable and inclusive housing into any part of this project.

8. First Reading

several weeks. He showed a slide of the Budget Key Points and said he was available to answer any questions.

9. Manager's Report

Village Manager Dave Fieldman introduced Deputy Village Manager Mike Baker.

Deputy Village Manager Baker showed a short video on the progress made on the Civic Center Project. He stated that the masonry was nearing completion and significant progress inside the Civic Center had been made, with most of the dry wall being installed. Additional ongoing work included permeable pavers being laid in the parking lot. Mr. Baker stated that the project remains on schedule and under budget.

Commissioner Davenport asked for confirmation that the Village avoided the need to pay for "Cold Weather Protection" by completing the masonry work now, before the weather were to change drastically.

Mr. Baker confirmed this is true.

10. Mayor's Report

There was no Mayor's Report.

11. Council Member Reports

Commissioner Davenport wished the Downers Grove North Football team luck at the State Championship on Saturday, November 25th. He wished everyone a Happy Thanksgiving.

Commissioner Glover also wished the Downers Grove North Football team luck and wished all a Happy Thanksgiving.

Commissioner Sadowski Fugitt spoke about a second instance of hate speech etched onto playground equipment in town and asked everyone to help by talking with neighbors, friends, and family. She said she looked forward to seeing everyone at the Grove Express 5k and the Village Tree Lighting. She wished everyone a Happy Thanksgiving.

Commissioner Tully reminded everyone that Long Range Plans (LRP) are set every several years by the Village and that the have been in existence for decades. He said that the Village does its best to communicate the LRP and he noted that the LRP includes plans and sometimes even just concepts. He used the downtown as an example, stating that designs have not been put forth for consideration yet. The Commissioner also spoke about video gaming, and the result being much different than what the public expected; this was because of all of the conversations that happened and also because of the public input. He then stated that the Grove Express 5k was taking place on Thanksgiving Day at 8:30 a.m. He also wished Downers Grove North luck in the State Championship game. Commissioner Tully wished everyone a wonderful Thanksgiving holiday and said that he was grateful to have the opportunity to serve with his fellow Council members and for the opportunity to be of service to the community.

Mayor Pro Tem Hosé wished Downers Grove North luck. He also reminded all about the Holiday Tree Lighting event on Friday, November 25th @ 4:30 p.m. The Mayor Pro Tem also shared the history and meaning of Thanksgiving. After hearing about the antisemitism in the County, and in the Village, Mayor Pro Tem Hosé encouraged everyone to give thanks for all that they have and for everyone among us.
