SYNOPSIS

The Village Council will pass ordinances establishing and abating certain tax levies on December 12, 2023. The levy must be filed by December 31, 2023.

STRATEGIC PLAN ALIGNMENT

The goals for 2023-2025 include Steward of Fiscal, Environmental and Neighborhood Sustainability.

FISCAL IMPACT

Without the abatement of any debt, the proposed levy is estimated to be \$29,947,548. However, it is recommended that tax levy abatements totaling \$6,352,457 which would abate all Village debt, be approved. Therefore, the net taxes to be raised by taxation for 2023 upon the taxable property are \$23,595,091 which includes the levy for the Village, Special Service Areas and the Public Library. The Village portion of the levy after abatements is estimated to be \$16,887,831. This levy amount is reflected in the FY24 budget.

RECOMMENDATION

Approval on the December 12, 2023 Active Agenda.

BACKGROUND

The tax levy process requires the adoption of the motion presented in advance of the following:

•	Publication of Truth in Taxation Notice and Announcement of Public Hearing	11/24/23
•	Public Hearing on Tax Levy	12/05/23
•	Adoption of Tax Levy	12/12/23
•	Abatement of Certain Debt Levies	12/12/23
•	Last day to file Levy with the County	12/31/23

Annually, the Village Council is required to levy taxes for the following 1) Village Services defined as corporate/police, fire protection, police pension, fire pension, the total amount of all General Obligation (G.O.) Bond payments due for the fiscal year, 2) Library operating and 3) all Special Services Areas.

Following the levy of taxes, the Council may *abate* or reduce the levy (reduce the property tax collections) for the specific amount that the Village has other resources available to pay for debt service. The amount to be abated is determined by the budget when specific revenues such as water revenues that are identified to pay for bonds issued to improve the water system, and revenues from stormwater and capital funds that are available and budgeted for debt service.

AN ORDINANCE ABATING A PORTION OF THE 2023 TAX LEVY RELATED TO THE GENERAL OBLIGATION REFUNDING BONDS, SERIES 2016

WHEREAS, the Council of the Village of Downers Grove, DuPage County,
Illinois, pursuant to the provisions of Article 8 of the Illinois Municipal Code, has
heretofore adopted an ordinance levying taxes for the corporate purposes of the Village
of Downers Grove for the fiscal year commencing on the first day of January, 2023, and
ending on the thirty-first day of December, 2023, (hereinafter referred to as the
"Ordinance"), which Ordinance shall, pursuant to law, be filed in the office of the
County Clerk of DuPage County, Illinois; and

WHEREAS, the Ordinance provided for a levy for funds budgeted for the General Obligation Refunding Bonds, Series 2016 (Ordinance 5525 adopted February 9, 2016) in the amount of \$177,800.00; and

WHEREAS, the Village of Downers Grove has sufficient funds available in the Corporate Fund to abate a portion of the amount of tax to be levied for the General Obligation Refunding Bonds, Series 2016 and to reduce the amount of tax to be levied pursuant to the Ordinance accordingly,

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

SECTION 1. That the funds available in the Corporate Fund of the Village of Downers Grove be applied to the General Obligation Refunding Bonds, Series 2016 in the amount of \$177,800.00.

SECTION 2. That the amount of \$177,800.00 levied for purposes of the General Obligation Refunding Bonds, Series 2016 be abated from the tax levy for the fiscal year commencing on the first day of January, 2023, and ending on the thirty-first day of December, 2023.

<u>SECTION 3</u>. That the Clerk of the Village of Downers Grove, DuPage County, Illinois, is hereby directed to file with the County Clerk of DuPage County, Illinois, a copy of this Ordinance, duly certified by said Village Clerk.

<u>SECTION 4</u>. That this Ordinance shall be in full force and effect from and after its passage as required by law.

<u>SECTION 5</u>. That all ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.
