#### **SYNOPSIS**

A resolution has been prepared to authorize a contract extension for the provision of streetlight maintenance and repairs to Rag's Electric, Inc. of Woodridge, Illinois in the amount of \$116,200.50.

### STRATEGIC PLAN ALIGNMENT

The goals for 2023 to 2025 include *Top Quality Infrastructure*.

#### **FISCAL IMPACT**

The cost for FY24 for this contract is \$116,200.50. The FY24 Budget provides \$30,000 in the General Fund. The remaining \$86,200.50 of the contract will only be authorized by staff in response to streetlight repairs generated by vehicle accidents reimbursable through the Village's risk management activities or for electrical work related to projects which include funding for this work.

## RECOMMENDATION

Approval on the January 9, 2024 Consent Agenda.

#### **BACKGROUND**

The Village maintains 1,475 streetlights as part of 110 distinct systems throughout the community. The purpose of this contract is to utilize the services of a contractor to complete repairs to street light systems including; troubleshooting electrical issues or replacing faulty underground cable, repairing controller issues, in addition to repairing streetlights knocked down or damaged as a result of vehicle accidents.

A Call for Bids for streetlight maintenance services was issued in 2021. Rag's Electric Inc. was the low bidder, and was awarded a three year contract with the option for two annual extensions. The contract extension for 2024 includes a 1% increase in the contract prices from 2023.
