SYNOPSIS

A resolution has been prepared to approve an amendment to the contract with Armstrong Relocation for decommissioning services to add additional work related to the Civic Center Project, resulting in a total not-to-exceed cost of \$83,880.

STRATEGIC PLAN ALIGNMENT

The goals for 2023-2025 include Exceptional Municipal Services and Top Quality Infrastructure.

FISCAL IMPACT

The project budget for the Civic Center Project includes funding for decommissioning and moving services.

RECOMMENDATION

Approval on the March 12, 2024 Consent Agenda.

BACKGROUND

Last year, the Village conducted a request for proposal (RFP) to select a qualified firm to perform decommissioning services for the current Village Hall and Police Department. Four firms responded to the RFP, and Armstrong Relocation was determined to have submitted the lowest qualified proposal. As plans for moving services related to the Civic Center Project were further defined, it was determined that Armstrong Relocation is qualified to perform the moving services most effectively and efficiently in coordination with decommissioning process. A proposal for moving services was subsequently provided by Armstrong Relocation. Staff recommends approving an amendment to the decommissioning contract with Armstrong to increase the scope of work to include moving services, and including a 10% price contingency for the full scope of decommissioning and moving services.
