Removal of William Nienburg from the Library Board of Trustees

Comment: Dear Mayor and Council,

It's been over a month since the Downers Grove Library Trustees voted 5-0 to remove Trustee Neinberg due to a violation of his oath, but also due to the over 14 months of disfunction and delay on the work of the library since his appointment. Since his appointment hate groups like the Proud Boys, and very partisan organizations like Awake Illinois, attend the meetings causing hostility, making threats and creating an unsafe environment for the other Trustees, the Library Director and other staff. He has not advanced any initiatives to improve library function or finances, but routinely makes negative blanket statements about the Director, staff and work of the library, feeding a small minority of meeting attendees, some who do not live in our community, who boo, yell, disrupt and congregate in an aggressive manner before and after meetings.

I am not advocating this removal because I think differing viewpoints should be silenced. Actually, the other 5 Trustees don't agree all of the time, and certainly before Trustee Neinberg joined there were disagreements on decisions, but that didn't lead to long delays, 4 or 5 hour meetings going over the same ground, and highly acrimonious meetings with numerous audience interruptions. Before Trustee Neinberg joined as Trustee, the other Trustees and Staff were not routinely called despicable names on social media, harassed in person or requiring police escorts. Trustee Neinberg is a polarizing and unhelpful member of this board, not the victim he is claiming to be. It is time to recognize a mistake was made with this appointment and also time for the Council to take a leadership role in rectifying the mistake.

The other five Trustees are owed our appreciation for persevering under extreme circumstances and so to our Library Director and Library staff. Please show all of them your support and the people of Downers Grove who use our libraries. When Trustee

Neinberg's supporters reveal they don't use the library at all or don't live in Downers Grove, then it should be clear that they are not the people you should listen to about this situation.

Thank you for reading and thank you for supporting a very important public institution in our community - our public library.
