SYNOPSIS

A resolution has been prepared to declare certain vehicles as surplus property and to authorize disposal of such property pursuant to Section 2.35 of the Municipal Code.

STRATEGIC PLAN ALIGNMENT

The goals for 2023-2025 include Steward of Financial, Environmental and Neighborhood Sustainability.

FISCAL IMPACT

Staff has established minimum bids for all surplus items. The combined total of the minimum bids is \$32,000. Funds resulting from the disposal of the surplus vehicles will be revenues in the Equipment Replacement Fund if the vehicle is a Village fleet vehicle, or earmarked for police activities if the proceeds are from the sale of a seized vehicle.

RECOMMENDATION

Approval on the November 12, 2024 Consent Agenda.

BACKGROUND

When the Village replaces vehicles or equipment, staff declares them surplus to be sold or disposed of. The attached schedule lists each vehicle to be declared surplus. Staff has established minimum bids for vehicles based upon conservative Kelly Blue Book values. The Village Manager or his designee may accept a bid below the minimum stated if needed.
