#### **SYNOPSIS**

A resolution has been prepared to authorize a contract extension for the provsion of a supply of crushed limestone from Boughton Materials Illinois, LLC, of Plainfield, IL in the amount of \$66,040.97.

# **FISCAL IMPACT**

The FY24 Budget includes \$20,000 remaining in the Water Fund, and \$5,000 remaining in the General Fund to cover crushed limestone purchases through the remainder of FY2024. The proposed FY2025 budget includes a total of \$50,000 for this contract.

- \$16,000 in the Storm Water fund.
- \$24,000 in the Water fund.
- \$10,000 in the General fund.

#### RECOMMENDATION

## **BACKGROUND**

This contract was competitively bid in 2023, and the awarded amount of \$48,906 was under the approval amount of the Village Manager. The contract extension for 2024 in the amount of \$49,395.06 was approved by Village Council on January 16, 2024. The second contract extension for 2025 is in the amount of \$66,040.97, and brings the three year contract total to \$164,342.03. The contract amount for FY2025 is based on approximately 3,500 tons of crushed limestone required for street, storm water and water utility system maintenance.

# SECOND EXTENSION TO THE AGREEMENT BETWEEN THE VILLAGE OF DOWNERS GROVE AND BOUGHTON MATERIALS OF ILLINOIS, LLC

The Village of Downers Grove, Illinois and Boughton Materials of Illinois, LLC entered into a contract for the purchase of specified crushed limestone on or about February 8, 2023 (the "Agreement"). Pursuant to the terms stated therein, the parties previously extended the Agreement for a period of one (1) year. Pursuant to the terms of the Agreement, the parties desire to extend the Agreement for a second, one-year period under the following terms:

- The contract shall be extended through December 31, 2025.
- 2. The quantities of materials set forth the in Agreement shall be amended as follows:

Item	Estimated Quantity (Tons)
CA-6 (grade 8)	1,000
CA-7 (3/4")	2,500

- 3. The fees for the services contemplated by the Agreement shall increase by two percent (2%), which is an increase of \$987.80, for a total not-to-exceed price of \$66,040.97 for the year 2025.
- All other terms from the February 8, 2023 contract remain in full force and effect.
