Comment: The west side of Saratoga is composed of beautiful historic homes, and should not be included in downtown development.

The Key Recommendations for the Village's Guiding DG plan include promoting preservation of historic buildings and neighborhoods, and ensuring residential new construction, additions, and renovations complement the established character and scale of the established neighborhoods.

The neighborhood directly surrounding Prince Pond, a beautiful prominent public park that is central to this neighborhood, should be protected from high rise development. Prince Pond is a beloved and gorgeous park that is well-used year-round. Even though I live on the south side of Downers Grove, I go out of my way to visit there whenever I get the chance. This is a long established and historically significant neighborhood which should be preserved, high rise development shouldn't be allowed around Prince Pond.

In 1892, E. H. Prince platted this subdivision and constructed Prince Pond to be a focal point of this neighborhood. In appreciation of this, in 2002, the Downers Grove Park District recognized Prince Pond as an historic site. One of the houses adjacent to these six lots was a home built by Israel Blodgett's son Charles, and the home next to it was his barn and is now Landmarked.

The picturesque single family home neighborhood surrounding Prince Pond is a prime example of a historic neighborhood that we're lucky enough to still have in Downers Grove. I'm asking the Council to remove these homes/lots from the Future Land Use Map.

Comment: This is not a comment of a general nature, it is a comment about the agenda item: Council Member Reports: MOT 2024-10501 A. Library Board Advisory Referendum

Since Commissioner Davenport pulled this item from the November 12th meeting without comment, I have been trying to get answers from him, and the rest of the Council about who was consulted prior to drafting the motion, whether the pros and cons of a potential switch of the Downers Grove Library to a district library have been researched, and what the reasoning was regarding bringing this forward as an advisory referendum, seemingly without having even discussed it with the various stakeholders. I have received replies from Commissioners Sadowski-Fugitt, Gilmartin, and Hose, indicating that they do not know why Commissioner Davenport has chosen to bring this forward, and, in at least one case, did not know about it until the agenda was announced. I have not received responses from Commissioners Tully, Glover, or Mayor Barnett. Commissioner Davenport's response to my questions was that he would be answering "most of them" at tonight's council meeting.

Since Commissioner Davenport says he intends to address my questions at tonight's Council meeting, I am including them here.

Commissioner Davenport,

I have several questions regarding your motion to place an advisory referendum on the April ballot, concerning converting the Downers Grove Library to a district library.

1) With whom have you had conversations about this, prior to first placing it on the agenda for the Nov 12 meeting? Have you talked with any of the Library Board members about it? Have you talked with any of the board members of the Library Foundation? Have you discussed it with other council members, prior to placing it on the agenda for the Nov 12 meeting? Were there any other groups or individuals with whom you discussed this topic, prior to placing it on the agenda for the Nov 12 council meeting? If so, with whom?

2) Have you investigated the pros and cons of the library making such a switch? Will there be a presentation of such pros and cons before any vote on placing this referendum on the April ballot?

3) Why do you think that an advisory referendum is the right step to take at this point? At the moment, and noting that this impression could change depending on your answers to the questions in paragraph 1, it seems like this motion for an advisory referendum is being brought forth without having had a discussion with the various stakeholders. Who came up with the idea of putting this referendum on the ballot, and what is the goal of putting it before the people, without, seemingly, having worked through what the consequences would be?

Why did you decide not to bring this motion at the Nov 12 Village Council meeting, instead deferring it to the Nov 19 meeting? The text of the motion has not changed.

As a long time Downers Grove resident, thank you for your time in answering these questions.
