I write on behalf of the Downers Grove Board of Library Trustees with regard to Council Resolution 2024-10593, which seeks to place a nonbinding referendum on the ballot next April asking "Shall the trustees of the Downers Grove Public Library be elected, rather than appointed?" The resolution is scheduled for a vote on December 3, 2024, and was introduced at the Council's November 19, 2024 meeting.

We respond in detail below, but in short, based on the initial assessment that the unreasonably short timing of the Council's scheduled vote has allowed us to conduct, we believe:

the language of the referendum is nonsensical because we are aware of no legal mechanism to allow for the election of trustees under the existing library structure; the extensive legal and structural changes that would be required to implement an elected library board, such as becoming an independent taxing body separate from the Village, will have costs that will likely result in higher taxes for Downers Grove residents.

Regardless of the merits of the proposal itself, however, proceeding with the referendum on such a chaotic timeline is contrary to the best interests of our residents, and unprofessional to ask of a fellow unit of government—one that has existed in its current form for over 130 years. For that reason, we previously asked that the Council grant us the courtesy of delaying its vote by at least one month to allow us to prepare a proper report on the impact of proceeding with the proposed referendum, but to date, that request has not been granted.

We unequivocally ask that you vote no on this resolution.

The resolution itself is extremely problematic, given that I can find zero benefit in having an elected library board even before taking into account the millions of dollars and thousands of hours of work it would require. Clearly, a few self-interested proponents of this resolution are strongarming the Village into a rushed and chaotic vote. It appears no one, except the library's Board, has done any research about the impacts of having an elected library Board. The library's preliminary findings support that there is no benefit to DG citizens, and instead, numerous detriments (higher taxes and less staff time spend on the library's 2025 strategic plan, to name a few). Our library Board has been and is successfully meeting or exceeding its community's needs and financial and budgetary goals. Why should taxpayers or the library's budget suffer increases to placate self-intetested sponsor(s) of this resolution who likely have little or no knowledge or experience regarding library operations. I can assure you that I will vote against such an unnecessary and damaging referendum, but I hope that the Village exercises prudence at its next meeting and refuses to hold a vote on this issue. If any proponent of this resolution or person infavor of putting it to a vote is an elected official, I will vote against them in the next election.

I am writing to express my opposition to Council Resolution 2024-10593, which seeks to place a nonbinding referendum on the ballot next April asking "Shall the trustees of the Downers Grove Public Library be elected, rather than appointed?" I am dismayed by both the fact of the resolution as well as the warp speed with which the Village Council seems prepared to act on something that is of such huge import. My concerns fall into three large buckets. First, I am concerned about the lack of expressed rationale for even having such a resolution in the first place. What problem is the Village Council seeking to address by raising this resolution? The library has been enormously effective in recent years providing outstanding service to residents of Downers Grove that has resulted in well-deserved national recognition. I am not aware of any concerns raised by or to the Village Council about the management or effectiveness of the library. So, why mess with a good thing? This appears to me to be the quintessential "solution in search of a problem." Second, I am stunned by the speed with which the Village Council is intent on pushing this through. Even if there was a well-defined problem that the council was attempting to address, why the rush? Why not give the library board of trustees the time to research and respond to this before rushing it to a vote? Again, there isn't any identified problem that this resolution is addressing, much less anything of an emergency nature that requires such massive haste. Finally, third, the resolution itself is vague and unlikely to be understood by voters. From my own guick research, this resolution has potential major implications for the level of services provided by the library and its passage makes possible that residents will face an increased tax burden. Nothing in the language of the resolution though hints as the major structural change to a unit of government that provides essential services to residents of Downers Grove. If this resolution is to be put before voters, it should at least be drafted in such a way to makes it clear the massive impact it is likely to have on a beloved institution.

I urge the Village Council to vote against this resolution for all of the aforementioned reasons.

Comment: I am deeply concerned about a recent Downers Grove Village Council agenda item regarding placing an advisory referendum question on the April ballot asking whether the library should become an independent unit of government, separate from the Village.

The agenda item was not only a surprise—to library staff and trustees, several council members, and the community—it's also pointless and presumptuous on the part of VC, who has no authority to act on the issue.

IF the Village and Library want to consider operating separately, the procedure to move forward must be initiated by the library board or by petition (from 10% of voters). Not Village Council.

Instead, VC is inexplicably rushing to place a purposeless question on the ballot of a low-turnout election while skirting any accountability. Mayor Barnett feels "no particular obligation" to educate voters. It seems all responsibility–from educating voters to responding to results–is placed squarely on the library, who did not request this.

On December 3, VC will vote on whether to include this now stripped-down question, devoid of any context to the ballot: "Shall the Downers Grove Public Library Board be

elected, rather than appointed?" Omitted is that an additional government body, costing taxpayers significantly more money, would be created first.

Until recently, VC used an incorrect process for appointing trustees (mayor-led vs. full council). Three recent appointments, utilizing the correct collaborative process, have gone smoothly.

Only two DG library trustees have ever been removed. Both were seated using the incorrect process. Both displayed open disdain for the institution they served. And both were appointed by members currently serving on VC (Barnett and then-mayor Tully), who remain indignant at being held accountable. I'm not surprised that rather than hold themselves accountable to their constituents, they prefer to dictate when and how the library should be accountable to theirs.

I am writing to document my opposition to RES 2024–10593 and to urge your "nay" vote.

My parents brought our family to Downers Grove in 1987. As a child, the DG Public Library was my haven. The librarians knew and welcomed me, whether it be in the stacks or at the Teddy Bear Picnic in Fishel Park. It was that safe "third space" where

my friends and I could spend our afternoons and evenings as adolescents to study and connect and be ourselves. This is where I had my first job as a teenager, with a manager who still works at the library, who still remembers me, and who now makes my own daughter feel like she belongs. The library was central to my development and, frankly, to my choice to return to the village and rent an apartment downtown (so we could be within walking distance!).

I imagine many of us who have grown up in Downers Grove, who have made it our home, who are raising our own families here have similar stories and warm memories of this nationally-recognized institution. RES 2024–10593 threatens this vital institution and its role in our community.

I find the resolution deeply troubling for the following reasons:

- Commissioner Davenport has provided no evidence or rationale to substantiate the need for this significant restructuring of the library's governance. Transparency is a cornerstone of good governance, yet this proposal has been presented without adequate context, explanation, or stakeholder input. If the stated goal is to enhance transparency, then the absence of supporting information undermines that very objective.
- It is concerning that no discussions appear to have taken place between the commissioner, the library staff, or the library board. The Village's vision statement emphasizes that DG "will be a hub for inclusiveness, acceptance, mutual respect and cultural excellence, fostering a strong relationship with community institutions to promote an excellent quality of life and community pride." The rushed timeline and unilateral approach to placing this divisive item on the council agenda contradict these values.
- The timing of this proposal—just two weeks before the deadline to adopt a resolution for the April ballot and during the Thanksgiving holiday period—severely limits opportunities for public engagement, council deliberation, and meaningful discussion. Such a truncated process is not conducive to informed decision-making on a matter of this magnitude.
- The proposed resolution to introduce a non-binding vote is no simple matter. I am troubled some of our commissioners see it as such; that suggests to me they do not have a firm understanding of what is being proposed, and that the choice to rush this through has provided them with only a surface-level grasp of the matter. If current Illinois law does not support the election of trustees under the library's existing

governance structure, then implementing the change would necessitate an extensive and costly structural and legal process—which would be profoundly complex.

- The resolution provides no analysis of the financial impact of restructuring the library board, including the potential costs to the Village, library, and taxpayers. This omission is inconsistent with the council's fiduciary responsibility. Additionally, the rushed nature of this proposal has already required the reallocation of human resources unnecessarily.
- Commissioner Davenport's stated desire to place the library board under the explicit control of the Village Council raises serious concerns about intellectual freedom and free speech. In the current climate of national and local challenges to libraries, education, and the advancement of knowledge, this proposal is not only ill-advised but chilling.
- The Downers Grove Public Library has a proven track record of excellence, as evidenced by its 2022 recognition as one of the top ten libraries in its budget class, its more than 1 million circulated items in 2023, and a 20% increase in in-person visits from 2022 to 2023. This performance clearly demonstrates the library is well-governed and thriving under its current structure. The library operates transparently and demonstrates its accountability to its stakeholders (for instance, the information in this paragraph is publicly available on its website). Suggesting otherwise without evidence is misleading and undermines public trust in this highly-valued institution.

The rushed nature of this proposal, pushed through without stakeholder input, suggests a poor understanding of its implications and an unnecessary attempt to advance a personal agenda at the expense of the library's independence and the community's trust. I urge you to reject RES 2024–10593 and instead prioritize fostering collaboration and thoughtful governance in line with Downers Grove's vision statement.

Comment: Comment on ESP overall vision statement — a science-based alternative

Through individual and collective effort of the community and its village government and associated governmental entities, the village of DG will become a suburb whose way of living is ecologically sustainable (ECOS), modeling for others both what this means and how it may be achieved.

An ECOS way of living means at a minimum a way of living that uses resources at a sustainable rate.

This principle in turn translates into at least three key objectives:

- (i) using renewable resources at a rate no greater than the rate at which they renew,
- (ii) shifting from using non-renewable resources, whose supplies are by definition limited and deplete with use, to renewable resources,
- (iii) using resources at a rate that allows every individual and group the opportunity and the means to develop to their potential
- a) as curious, capable, purposeful, and wise individuals and groups,
- b) as productive, empathic, and valued members of the group(s) of which they are a part, and
- c) as members of a species ever in awe of life and its ecological complexity, which is to say, treasuring the existences of both
- c.1) our species, as individuals, groups, and as a whole, and the vast array of other species with which we share the planet, those that have passed, and those yet to come, and
- c.2) the planet and its enfolding universe, whose existences in all their material complexity make life possible.

+++++

Axioms

Because we currently live in a world in which the way of living is NOT ECOS,

1. the jointly shared goal of the species (humanity) must be to reduce the global rate of resource consumption to a sustainable one, by lowering the rate of consumption of the rich — in other words, reducing the overall rate of consumption by reducing both more quickly and more substantially the rates of consumption of the more resource-rapacious social classes — in order to free up the resources needed to meet condition 3 above.

Because humans have learned to use material forms of energy to amplify their physical and mental capacity to do work, which make that amplification the foundation of our current ecologically UNsustainable way of living,

2. the task of achieving a sustainable rate of resource usage unavoidably entails reducing first and foremost the rate of usage of energy of all non-renewable forms.

[footnote: So-called 'renewable energy' is more aptly called "renewably sourced, non-renewably collected, stored, distributed, and used energy".]

- 2a. Humanity's heavy reliance on especially coal and oil for energy means a 'controlled' rate of reduction in usage (to minimize frivolous or ostentatious usage and avoid military conflict over shares of usage) unavoidably involves ascertaining remaining supplies and negotiating equitable sharing of those supplies.
- 2b. The magnitude of this abstinence task unavoidably requires the great proportion of humanity must accept that
- i) their present way of living (embodied in both physical and social structures) is not sustainable,
- ii) they must completely re-imagine what a sustainable way of living looks like,
- iii) they must strive to optimize resource usage when undoing the present way of living, especially ...
- iv) striving to optimize 1) the use and reuse of extant structures containing and using non-renewable resources and 2) the use of the remaining untapped reserves of non-renewable resources.

Absent equitable and optimal sharing of resources, ...

3. humans will likely be unable to achieve an ECOS way of living peacefully and willingly and will be subjected to history's usual 'nature-based' mechanisms for achieving sustainability: natural disaster, disease, famine, and war over resources.

======

Our Predicament: the obstacle to actions presented by the interconnected economy

Because an ECOS way of living is by definition a global necessity for our species and because of the present worldwide interconnectedness of political economic life, with few people living solely or even principally on the resources in their immediate vicinity, meeting the goal at the global level necessitates cooperation at all levels of society.

At present, this seems like a political economic pipe dream. Which is to say: resource wars are already occurring, whether people recognize and leaders acknowledge this reality or not.

Interconnectedness means residents of a municipality (whatever its size) striving for 'sustainability' must recognize and acknowledge that almost all of its resource load is produced and maintained outside its boundaries, both the resources themselves ultimately consumed within the municipality and all the infrastructure (physical and political economic) required to transport the consumable resource (food, goods, services — including workers) in and the waste out.

Rather than trying to account for this complexity, individual municipalities seeking to be 'more sustainable' tend to focus solely on the consumption of certain resources within their municipal boundaries, adopting a voluntary, easy-to-shoot-for-target(s) approach rather than a systematic, coordinated, and systemic one.

Little attempt is made to actually reduce the total load of the municipality's way of living because no one has any idea what that load is or how to share reducing it across the networked entities to which the municipality is connected.

That is, municipalities have little knowledge of either the totally of the resources consumed to provide the resources consumed directly to maintain and/or enhance their way of living or the totality of resources directly consumed within the municipality itself.

Which then means: actions typically undertaken within a municipality amount to greenwashing when residents are encouraged to believe the municipality is becoming 'more sustainable' when neither residents nor organizations nor the municipality's government have data on which to base that assessment.

The underlying justification for adopting such an approach, however, is that 'doing something is better than doing nothing.'

The claim is patently self-deluding in this context.

It's analogous to making a few small changes while continuing unhealthy personal habits or living beyond one's means.

Believing "doing something is better than doing nothing" in the current situation is analogous to paying the minimum balance on one's credit card bill and expecting the creditor's patience and line of credit will never run out.

Unfortunately, in the case of ECOS, notice of profligacy does not show up in the mail each month in a bank statement or credit card statement pointing out resource reserves are dwindling.

We now have decades of evidence showing that neither worsening global data nor worsening individual natural disasters have yielded an impact on the most profligate — the people living in rich nations such as the US and property-rich places such as DG — motivating them to change behavior sufficiently.

Thus, given the challenge of people undoing decades of political economic activity undertaken at every level of society, all of it done oblivious to the boundary imposed by the need to live ECOS, one is hard-pressed to believe humans living in rich nations are going to act dramatically enough unless and until things get much worse FOR THEM and they have no choice.

++++++++

Regarding the proposed ESP:

The effort to put together DG's proposed ESP was for all practical purposes invisible to residents.

Although GuidingDG made a modest effort to solicit resident input on the notion of "environmental sustainability" (a phrase universally misused, including in DG), it yielded the expected stereotypic responses of desire for clean air, water, and the like. But it did not try to probe residents understanding in any in-depth fashion.

The community's low level of understanding is in turn reflected in the low level of understanding of the subject matter displayed by the members of both VC and the ECC.

As I have noted previously, members of the ECC characterize themselves as dabblers, so it is hardly surprising the proposed ESP takes the form and substance it does.

The ESP put forward by the ECC for VC's attention cannot even bring itself to state explicitly that DG's current way of living is not ECOS.

An informed reader can read between the lines and detect hints of that conclusion, but the uninformed reader is unlikely to do so, particularly when the goals the ESP proposes amount collectively to the timid recommendation 'everyone needs do something, because doing something is better than doing nothing.'

The ESP gives no indication how one gets from 'doing something' to 'doing enough;' in that it offers no indication what IS 'enough.'

Which means, as I suggested above, doing something is 'better' only if the ESP's prime objective is individual and community conscience-laundering.

In that regard, the proposed ESP is consistent with the sustainability plans municipalities typically put together, but that consistency undermines the ESP's claim the goal of the plan is to be a model.

Which also means it's woefully inadequate for dealing with a situation that is deadly serious and urgent.

Comment: Dear Mayor Barnett and Village Council:

I write on behalf of the Downers Grove Board of Library Trustees with regard to Council Resolution 2024-10593, which seeks to place a nonbinding referendum on the ballot next April asking "Shall the trustees of the Downers Grove Public Library be elected, rather than appointed?" The resolution is scheduled for a vote on December 3, 2024, and was introduced at the Council's November 19, 2024 meeting.

We respond in detail below, but in short, based on the initial assessment that the unreasonably short timing of the Council's scheduled vote has allowed us to conduct, we believe:

the language of the referendum is nonsensical because we are aware of no legal mechanism to allow for the election of trustees under the existing library structure; the extensive legal and structural changes that would be required to implement an elected library board, such as becoming an independent taxing body separate from the Village, will have costs that will likely result in higher taxes for Downers Grove residents.

Regardless of the merits of the proposal itself, however, proceeding with the referendum on such a chaotic timeline is contrary to the best interests of our residents, and unprofessional to ask of a fellow unit of government—one that has existed in its current form for over 130 years. For that reason, we previously asked that the Council grant us the courtesy of delaying its vote by at least one month to allow us to prepare a proper report on the impact of proceeding with the proposed referendum, but to date, that request has not been granted.

We unequivocally ask that you vote no on this resolution.

The current process by which trustees are appointed and reviewed by the library board provides the most robust system of checks and balances to ensure our trustees are qualified for their roles. I do not support bringing to ballot the option to elect trustees rather than appoint them, and I do not support the village taking the next implied step of separating the library from the village to become its own independent unit of government. I have clearly seen in other communities that this move is an inefficient one, both increasing the tax burden on residents and reducing resources and programming for the library and its patrons. I appreciate the current arrangement and the financial efficiencies it provides to taxpayers and library patrons, allowing our library to shine as one of the best in the area. Our peer communities with similarly award-winning libraries are not seeking this arrangement for a reason: It's a lose-lose for the community.

I encourage the Village Board to vote "NO" to Council Resolution 2024-10593.
