SYNOPSIS

A resolution has been prepared to approve a one year extension to a previous 3-year agreement with Adventist Bolingbrook Hospital (f/k/a AMITA Health Adventist Medical Center Bolingbrook) for annual Fire Department Fit for Duty Medical Exams in a not-to-exceed amount of \$50,000.00.

STRATEGIC PLAN ALIGNMENT

The goals for 2023-2025 include Exceptional Municipal Services.

FISCAL IMPACT

The FY25 Budget provides \$50,000 in the General Fund for this contract.

RECOMMENDATION

Approval on the January 21, 2025 consent agenda.

BACKGROUND

The Fire Department conducts annual fit for duty medical exams for all fire suppression personnel. The fit for duty exams are conducted in accordance with the National Fire Protection Association (NFPA) Standard 1582 - Medical Requirements for Firefighters. Fit for duty exams are used to determine if a firefighter is able to perform the duties of a firefighter without medical restriction and to determine if a firefighter is medically cleared to wear a respirator.

Fit for duty exams have been conducted by the Fire Department since 1996. Fit for duty exams are a contracted service. In accordance with the Village purchasing policy, an RFP was developed in 2021 to seek qualified vendors to provide fit for duty exams. Fire Department staff reviewed three RFPs that were received. Amita Health Bolingbrook Medical Center provided the lowest cost quote and has provided the Fire Department with excellent services; including scheduling appointments, reporting, and invoicing.

EXTENSION AND AMENDMENT OF THE ANNUAL OCCUPATIONAL MEDICAL EVALUATION AND FITNESS FOR DUTY EXAMINATION AGREEMENT BETWEEN THE VILLAGE OF DOWNERS GROVE AND ADVENTIST BOLINGBROOK HOSPITAL

This Extension and Amendment is entered into by and among <u>The Village of Downers</u> <u>Grove</u> and <u>Adventist Bolingbrook Hospital</u> (f/k/a AMITA Health Adventist Medical Center Bolingbrook).

WHEREAS

- A. The parties hereto entered into an Agreement for annual occupational medical evaluations and fitness for fitness for duty examinations on or about February 15, 2022 ("Agreement"); and
- B. The current term of the Agreement will expire on December 31, 2024; and
- C. Pursuant to the terms stated in the Agreement, the parties hereto desire to extend that Agreement for a one-year period and amend the Agreement to incorporate a revised Exhibit A, as further set forth below.

Now therefore, in consideration of the mutual promises and covenants herein and other good and valuable consideration, the parties hereto agree as follows:

- 1. The term of the Agreement is hereby extended for a period of one year, from January 1, 2025 to December 31, 2025.

- 4. Reports

All reports will be provided as specified by contract and filled within 30 days of the examination. All Stress Tests and EKGs read by a Board Certified Cardiologist. CSTs Baseline then every 5 years unless medically indicated. Every year 40yrs and above. All Spirometry Tests will be reviewed by a Board Certified Pulmonologist. All X-rays and mammograms will be reviewed by a Board Certified Radiologist and will compare to prior reports. Baseline Mammogram will be provided for female members 40yrs and older and then bi-annually or if medically indicated and annually for those 50yrs and older or as clinically indicated.

Not Fit For Duty

If for any reason, a member is found "not fit for duty" by the examining physician, the physician will meet with the member to explain what portion of the exam is not in compliance. The physician shall forward a letter confirming his findings to the Director of Human Resources for the Village of Downers Grove, as well as the Fire Chief.
