Resolution Approving the purchase of PTZ Cameras from Flock Safety		Mike DeVries Chief of Police

SYNOPSIS

A resolution has been prepared to authorize the purchase and installation of two (2) additional pan-tilt-zoom (PTZ) cameras from Flock Safety.

STRATEGIC PLAN ALIGNMENT

The goals for 2023-2025 include *Top Quality Infrastructure and Exceptional Municipal Services*.

FISCAL IMPACT

The cost of this purchase is \$14,000. The Village was awarded Illinois Attorney General's Office organized retail crime grant funds, which will be used to fund this purchase and the first year of annual maintenance. Future maintenance will be budgeted accordingly.

RECOMMENDATION

Approval on the February 18, 2025 consent agenda.

BACKGROUND

The Police Department currently utilizes Flock Safety's Condor PTZ cameras in the downtown area, along with Flock Safety's proprietary FlockOS. This operating system allows cloud access to the Flock Safety Video Management System (VMS), where Condor PTZ camera video feeds can be viewed via the internet.

The grant agreement with Illinois Attorney General's Office organized retail crime grant funds allocated \$14,000 to be used for the purchase of PTZ cameras, which will be used to fund this purchase, as well as the first year of annual maintenance costs. Staff recommends purchasing two (2) PTZ cameras, with one to be installed in the Butterfield Road retail corridor and one to be installed in the 75th & Lemont retail area. Staff recommends purchasing these cameras from Flock Safety as the Police Department already uses the Flock Safety VMS platform to view live and recorded video feeds from Flock Safety's Condor PTZ cameras currently installed in the downtown business district. Flock Safety is a sole source provider for Condor PTZ cameras and FlockOS.
