BACKGROUND

The Village's FY24 Budget was authorized by ordinance in December 2023 and the Village's fiscal year began on January 1, 2024 and closed on December 31, 2024. The Village has nearly completed the financial closeout of the year and audit work will be completed in the coming weeks.

Actual FY24 expenses ended the year below budgeted levels for all Village Funds except one. However, due to higher than anticipated claims, the Health Fund will require a \$1,100,000 budget amendment.
