SYNOPSIS

STRATEGIC PLAN ALIGNMENT

The goals for 2025-2027 include *Steward of Financial, Environmental and Neighborhood Sustainability*.

FISCAL IMPACT

The FY26 Municipal Budget will provide for all operational revenues and expenditures for the time period from January 1, 2026 through December 31, 2026.

UPDATE & RECOMMENDATION

This item was discussed at the November 4, 2025 Village Council meeting. Staff recommends approval on the December 2, 2025 Active Agenda. The Downers Grove Economic Development Corporation, Downtown Management and the Downers Grove Public Library will present their budgets at the November 11 Village Council meeting.

**AN ORDINANCE ADOPTING THE FISCAL YEAR 2026
BUDGET IN LIEU OF PASSAGE OF AN APPROPRIATION ORDINANCE**

WHEREAS, the Village Council of the Village of Downers Grove has provided for the preparation and adoption of an annual budget in lieu of passage of an appropriation ordinance for the fiscal year 2026; and

WHEREAS, a proposed annual budget has been prepared, published by the Village Council and made available for inspection for at least ten days, all as provided by law; and

WHEREAS, notice has been given and a public hearing held on November 4, 2025, as provided by law; and

WHEREAS, the Village Council of the Village of Downers Grove has examined said annual budget and has heard all persons appearing and desiring to be heard concerning said annual budget,

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Downers Grove, in DuPage County, Illinois, as follows:

SECTION 1. That the tentative annual budget heretofore prepared by the Village Manager and placed on file as required by the statutes of the State of Illinois is hereby adopted in lieu of the passage of an appropriation ordinance for the fiscal year 2026 with the following amendments:
