Synopsis

A resolution has been prepared to authorize the execution of a one-year extension to the police uniform and equipment contract with Ray O'Herron of Downers Grove, Illinois, for an amount not to exceed \$138,462.50.

Strategic Plan Alignment

The goals for 2025-2027 include *Exceptional Municipal Services*.

Fiscal Impact

The Fiscal Year 2026 budget provides \$138,462.50 in the General Fund for this contract.

Recommendation

Approval on the June 2, 2026 consent agenda.

Background

In 2023, the Village entered into a two-year contract with Ray O'Herron for the purchase of police uniforms and related equipment. The term of the contract was subsequently extended by one year in 2025. Staff recommends entering into a second contract extension, with an effective period from May 1, 2026, through April 30, 2027. The collective unit pricing for clothing and equipment will increase by roughly 2% for the duration of the second extension.

Terms of the Collective Bargaining Agreement allow officers to purchase clothing or equipment at the fixed price established by the vendor, with billing direct to the officer. Police Department uniforms may be purchased by officers through the contract, individually for civilian clothing or equipment as necessary, or using the terms of the State contract.

A Resolution Authorizing Execution of a Second Extension to the Agreement Between the Village of Downers Grove and Ray O'Herron Company, Inc.

BE IT RESOLVED by the Village Council of the Village of Downers Grove, DuPage County, Illinois, as follows:

SECTION 1. That the form and substance of a certain Second Extension (the "Agreement"), between the Village of Downers Grove (the "Village") and Ray O'Herron Company, Inc. (the "Provider"), for the purchase of police uniforms and related equipment, as set forth in the form of the Agreement submitted to this meeting with the recommendation of the Village Manager, is hereby approved.

SECTION 2. That the Village Manager and Village Clerk are hereby respectively authorized and directed for and on behalf of the Village to execute, attest, seal and deliver the Agreement, substantially in the form approved in the foregoing paragraph of this Resolution, together with such changes as the Manager shall deem necessary.

SECTION 3. That the proper officials, agents and employees of the Village are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Village in accordance with the provisions of the Agreement.

SECTION 4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

SECTION 5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

**SECOND EXTENSION TO THE AGREEMENT
BETWEEN THE VILLAGE OF DOWNERS GROVE
AND RAY O'HERRON COMPANY, INC.**

The Village of Downers Grove, Illinois ("Village") and Ray O'Herron Company, Inc. ("Provider") previously entered into an Agreement for the purchase of police uniforms and related equipment on or about May 2, 2023 ("Agreement"), the term of which was extended for one additional year by agreement of the Parties ("Extension"). Pursuant to the terms stated therein, the parties desire to extend the Agreement for a second, one-year period under the following terms:

1. The fees set forth in the Agreement are hereby amended to those prices set forth on Exhibit A, attached hereto and incorporated herein by reference.
2. Provider shall continue to honor the pricing set forth on Exhibit A for all purchases made by the Village and any purchases made by police personnel employed by the Village.
3. The Agreement shall continue for a one-year period beginning May 1, 2026 and ending on April 30, 2027. All terms of the Agreement shall continue in full force and effect except as otherwise stated herein.
