Ms. Lippe provided an overview for the month of August:

- 69 referrals compared to 73 in 2024
- 97.75% overall acceptance rate
- 60 referrals included the 20-29 and 50-89 age cohorts
- Top 5 leading service type provided was senior, transportation, village, housing, and medical resources
- Top methods of awareness outside of department referrals was previous experience.
- The leading initiation category was residents/family members
- The top method of contact was telephone
- Social Worker was responsible for 94% of the referrals
- The declined referral was due to no valid contact information
- Attended the Dementia Conference and Aging Summit

 Participated in the 18th Judicial Family Violence Coordinating Council Housing Committee


Monthly Program Performance Measurements
